SMS has also opened , plantation areas of 5,500 hectares.

PT. Rejoso Manis Indo (RMI) which is a member of Berkah Manis Makmur Group is constructing a sugar plant in Blitar, East Java with an investment of Rp. 1.88 trillion. It controls sugarcane plantation areas of 23,000 hectares, consisting of 5,000 hectares of core plantation areas and 18,000 hectares of partnership system plantations (plasma). Investment fund of RMI came from a banking syndicate led by Bank Negara Indonesia (BNI); PT. Kebun Tebu Mas (KTM) which is a member of LABINTA Group spent an

investment of Rp. 2.5 trillion to construct a sugar plant in Lamongan, East Java with sugar production capacity of 1.08 million tons and molasses of 100 thousand tons per annum. It controls, plantation areas of 24,000 hectares. There are also other companies such as PT. Sumber Mutiara Indah Perdana (SMIP), PT. Usaha Ridha Semesta (URS), PT. Gendis Multi Manis (GMM) and other conglomerations of which the profiles are presented in this directory book.
